## 1. Contractual Relationship

- (a) These Terms & Conditions constitute a binding agreement between Desaru South Course Sdn Bhd (“The Els Club Desaru Coast - Ocean Course”) and the Privilege Pass Program’s holders (“you”, “your” or “Pass Holder”).
- (b) By signing this Privilege Pass Registration Form (“Form”), you confirm your agreement to be bound by these Terms & Conditions, as well as the Rules & Regulations, By-Laws and all other applicable terms relating to the use of The Els Club Desaru Coast - Ocean Course’s facilities (collectively “Terms”) of all which are available at [http://www.elsclubmalaysia.com/privilege\\_pass/](http://www.elsclubmalaysia.com/privilege_pass/). These terms expressly supersede all prior agreements or arrangements with you.

## 2. Privilege Pass Benefits & Terms

You acknowledge and agree that:

- (a) Subject to full payment of the Fee (see Appendix I) within 30 days from the execution date of this Form, this Privilege Pass program grants you access to The Els Club Desaru Coast - Ocean Course
- (b) Privilege Pass is an individual program for a person who is above the age of eighteen (18) years old (“Privilege Pass Holder”) and it is not transferable to another person.
- (c) Privilege Pass is not a membership program.
- (d) Privileges for the Pass Holder are as attached in Appendix I.
- (e) You will be given a pass card as an identification. You must show the pass card when requested by any of The Els Club Desaru Coast - Ocean Course personnel.
- (f) You must notify The Els Club Desaru Coast-Ocean Course’s management immediately if your Privilege Pass card is lost, stolen or destroyed. A replacement card will be subject to administrative charges as determined by The Els Club Desaru Coast – Ocean Course.
- (g) You agree that The Els Club Desaru Coast - Ocean Course may vary any of the Terms from time to time (“Amendments”) without reference to you. The amendments will be effective upon The Els Club Desaru Coast - Ocean Course’s posting of such updated Terms at the link mentioned in paragraph 1(b) above.

## 3. Golf Rules

- (a) You may golf any day, subject to reservation and availability.
- (b) You are entitled to only golf at Ocean Course.
- (c) You are allowed to bring up to 3 individual guests to golf with you. Your guests will be charged at the prevailing member’s guest green fee.
- (d) You may participate in The Els Club Desaru Coast – Ocean Course’s competition, subject always to the invitation and approval of The Els Club Desaru Coast - Ocean Course.
- (e) All drivers of golf carts must be at least eighteen (18) years of age or hold a valid driving license.
- (f) RM 25 cart fee applies for each visit.

## 4. Termination

- (a) If you breach any of the Terms, The Els Club Desaru Coast - Ocean Course may terminate this Form and your Privilege Pass in accordance with the Terms.
- (b) All Fee paid pursuant to this Form is non-refundable including early termination of the Privilege Pass.

## 5. General Terms

- (a) Time is of the essence of this Form.
- (b) These Terms are governed by and construed in accordance with the laws of Malaysia and both you and The Els Club Desaru Coast - Ocean Course irrevocably submit to the exclusive jurisdiction of the courts of Malaysia.
- (c) The Els Club Desaru Coast - Ocean Course shall not be liable for any indirect, incidental, special, exemplary, punitive or consequential damages suffered by you in connection with the Privilege Pass.
- (d) You shall indemnify, waive your rights and release The Els Club Desaru Coast – Ocean Course from and all causes of actions, claims or other liabilities of any nature whatsoever and howsoever arising which may result from your conduct in connection with this Privilege Pass and the Els Club Desaru Coast’s - Ocean Course’s facilities
- (e) If any provision of these Terms is held to be invalid or unenforceable, such provision shall be struck and the remaining provisions shall be enforced to the fullest extent under law.
- (f) The Els Club Desaru Coast - Ocean Course’s failure to enforce any right or provision in these Terms shall not constitute a waiver of such right or provision unless acknowledged and agreed to by The Els Club Desaru Coast - Ocean Course in writing.
- (g) You agree to indemnify and hold The Els Club Desaru Coast - Ocean Course and its affiliates and their officers, directors, employees, and agents harmless from any and all claims, demands, losses, liabilities, and expenses (including attorneys’ fees), arising out of or in connection with: (i) the Privilege Pass; or (ii) your breach or violation of any of these Terms.
- (h) The Els Club Desaru Coast-Ocean Course may assign or transfer in whole or in part its rights and obligations under this Form in favour of any third party without your consent.
